### **The privileges of this Appointment as “Enneagram Master Trainer, EWA” are:**

2. For participants of my trainings EWA membership is free of charge for the level where I issued them a correct EWA sealed certificate (for Membership Benefits please see: <https://www.enneagram-ewa.net/about/benefits> ).
3. I can advertise my EWA Enneagram trainings on the EWA websites so that interested people can search for my Enneagram trainings there.
4. I’m listed on the EWA website as “Enneagram Master Trainer, EWA” so that interested people can find me in the countries where I offer EWA sealed trainings through the EWA search machine and on Google Maps.
5. I have the right to use the title “Enneagram Master Trainer, EWA” and the EWA logo on websites and documents for marketing EWA trainings.
6. I can contribute materials (e.g., articles, webinars, eLearning online courses, assessments) to the EWA website for members and potential members and discuss special topics in the EWA discussion forum for members.
7. I can create special qualifications with the written approval of the EWA Training Commission.
8. I have the right to vote on Membership Meetings for seal entitled “Enneagram Master Trainer, EWA”.

**The responsibilities of this Appointment as “Enneagram Master Trainer, EWA” are:**

1. I adhere to the EWA Ethics Codex and the EWA quality standards for sealing with EWA, incl. my Continuing Professional Development (CPD) and follow the EWA “Certification Guidelines”, incl. the rules and regulations regarding EWA Curricula, Training Standards, Titles and Certificates. The EWA Ethics Codex includes as well, that I fulfil all legal requirements and abide by the laws of the country where I offer my service and practice.
2. I keep all information updated in my profiles on the EWA websites and I’m fully responsible for all content including links to other websites that I have placed on the EWA website.
3. I stand up for EWA. That means that I actively support the good reputation of EWA and of Enneagram, that I’m a point of reference for others who want information about EWA, that I place an active link from the EWA logo on my website, and that I support the EWA marketing and the World Congresses of IN ICI WHO WSCO PosPsy In-Me and EWA.
